

**REGISTRATION INFORMATION
SCHOOL YEAR 2021-2022**

Parents, carefully read the following information as it pertains to registration for both morning care and after school care for the upcoming year.

PLEASE NOTE THE FOLLOWING:

- ALL MEDICAL INFORMATION PERTAINING TO YOUR CHILD MUST BE COMPLETELY UP TO DATE IN ORDER TO BE REGISTERED FOR THE NEW SCHOOL YEAR (TO INCLUDE CURRENT SHOT RECORDS FOR ALL STUDENTS, AS WELL AS VISION AND HEARING TEST RESULTS FOR STUDENTS ENTERING THE 4 YR. OLD CLASS).
- In accordance with school policy, all accounts **MUST BE CURRENT WITH NO OUTSTANDING BALANCE** in order to process registration.

REGISTRATION INFORMATION FOR ALL MORNING CLASSES:

- REGISTRATION FEES - \$150 MUST BE PAID BY CHECK AT TIME OF REGISTRATION AND ARE NON-REFUNDABLE. IF A STUDENT WITHDRAWS DURING THE SCHOOL YEAR AND WISHES TO RETURN DURING THAT SAME SCHOOL YEAR, A NEW REGISTRATION FEE OF \$150 WILL BE CHARGED, IF THERE IS A PLACE OPEN. OTHERWISE, THE CHILD'S NAME WILL BE PLACED ON THE WAITING LIST IN ORDER RECEIVED.
- February 16th- 19th – Natural Flow, Repeaters and Siblings of current students (in this order) begin. We will begin accepting Registration packets beginning the week of February 16th, in the Wesley Hall. Registration packets are due by NOON on February 19th, all packets will be time stamped and processed in the order received. Your option of choice will be determined by the date and time stamped on the Registration Option page.
- February 21 – Registration for members of FUMC, not currently enrolled, begins at 9:30 a.m. and continues to 10:30 am in the Day School Office.
- February 22 – Open registration for the public begins at 10:00 am and continues until 11:00 am on Monday and Wednesday, in Wesley Hall, until all spots have been filled.
- Tuition information is available on the attached schedule. Tuition for August will be pro-rated for the number of school days scheduled and invoiced on the September Invoice.

REGISTRATION INFORMATION FOR AFTERNOON EXTENDED CARE

PLEASE NOTE THE FOLLOWING:

CHANGES FOR EXTENDED CARE WITHOUT PENALTY CAN BE MADE IN THE DAY SCHOOL OFFICE OR BY TELEPHONE UP UNTIL THE FIRST INVOICE, SEPTEMBER 1ST. ALTERATIONS AFTER THE FIRST INVOICE WILL REQUIRE THE TWO-WEEK NOTICE STATED IN THE HANDBOOK.
